

COVID-19 RISK ASSESSMENT

This Risk Assessment only covers the risk to individuals being exposed to Covid-19 whilst taking part in Scouting Activities during the Covid-19 pandemic. It does not cover other risks associated with the running of those activities and Leaders should separately refer to the 2nd Onchan Risk Assessments for use of the Scout Hall and Outdoor Activities. A dynamic risk assessment should be continually carried out by Leaders in line with Isle of Man Government Guidelines.

The Isle of Man currently has no active Covid-19 cases in the community. The risk of catching Covid-19 is therefore exceptionally remote at present given that there are no Covid-19 community cases. This risk level remains whilst the Island's borders are closed and so few control measures are necessary and proportionate. Social distancing regulations have been removed by the Isle of Man Government.

If an individual presents with symptoms they will be asked to leave and the session ended. The Hall will then be deep cleaned and no persons permitted to use the same until this has been completed.
